## **WORKSHOP**

### **The Allocation of Risk and The Duties and Responsibilities of the Dispute Adjudication Board under the FIDIC Contract**

The DRBF, in conjunction with FIDIC and TechnoBee, is pleased to present a two-day Workshop in conjunction with its 10th Annual International Conference. This workshop will deal with two aspects of risk allocation in the FIDIC Conditions of Contract for Plant and Design-Build and EPC Contracts: the first involving the treatment of common risk events and the handling of claims by the Parties to the Contract and the Employer's Engineer/Representative and the second with the duties and responsibilities of Parties, the Engineer and the Dispute Adjudication Board in the resolution of disputes that commonly arise under this form of contracting.

This training workshop will extend over two days and will feature three separate sessions on each of the two days dedicated to focus on the six topics. Each of the sessions will consist of one and a half hours of interactive training in small groups, each led by an experienced DRBF panel of tutors. The workshop will be closed by a plenary discussion.
