


Does inclusion of a DRB provision in the contract affect your willingness to bid on a project?








Does inclusion of a DRB provision in the contract affect your bid price?







Of the DRB hearings you have been involved with, how many would you estimate resulted in a favorable recommendation?










Does your organization typically accept a DRB recommendation regardless of outcome?













Are your organization's decision makers (the ones who decide to accept or reject a DRB recommendation) typically present at the routine DRB meetings and hearings?








Do you believe DRBs reduce the amount of "spurious" or minor claims merely by the existence of the DRB?










Have your DRBs been instructed to strictly follow the terms of the contract when setting out guidelines for meetings and hearings?








How should disputes between and contractor and sub-contractor be handled?








On a 3-member DRB, how many members should have specific experience with the planned type of project (such as heavy construction experience as a contractor, or geotechnical design experience for a transit project)?








How important is training in DRB processes and procedures?








How satisfied are you with the available pool of impartial, experienced, and trained DRB candidates?








How should DRB members be evaluated for impartiality, experience and training? (check all that apply)








Does your agency/department use the latest DRBF recommended documents such as DRB Agreement (formerly third-party agreement) and Operating Procedures?








As COVID wanes, will you be returning to in-person DRB meetings, staying virtual, or some combination?








What do you consider the best method for DRB member selection?








Should attorneys be allowed to serve as DRB members?







Do you believe an individual should be limited to the number of DRBs they serve on concurrently, in order to ensure availability for meetings and hearings?








How proactive should the DRB be in hearings?

Whatever is best, in the DRB's judgment, to facilitate settlement of the dispute

Very proactive: Ask leading questions or questions that could be construed to express disbelief with presentation, ask for documents that have not been tendered by either party (discovery), etc.


Not proactive: The DRB should respond strictly to the parties' presentations








What material should be presented at a hearing? (mark all that apply)?










What has been your experience with the quality of the written DRB recommendations (emphasis on the Finding of Facts that support the recommendation)?








Do you believe DRB decisions should be binding or non-binding?








In the case of a binding decision, do you believe either party should have a right to protest and invoke other mediation or arbitration (other than litigation)?








When should DRB recommendations be admissible in subsequent dispute resolution/litigation?








Under what circumstances should either party have the ability to terminate a Board member? (mark all that apply)
