



Dispute Board costs as a percentage of the total value of the Project (Individuals' responses)



How often were dispute avoidance measures adopted? (Individuals' responses)



Result after the implementation of dispute avoidance measures (Individuals' responses)





How often did parties comply with non-binding recommendations of Dispute Boards? (Individuals' responses)



How often did parties voluntarily comply with binding decisions of Dispute Boards? (Individuals' responses)




