The State of Disputes: Interim Findings of JICA's Survey on DB

Background: JICA's Policy on DB

Criteria of application of DB provision

Contract Amount \$1=JPY135	Type of DB
Over JPY 10 billion (\$ 74 million)	Standing DB/3 members (required)
Over JPY 3 billion (\$ 22 million) and less than JPY 10 billion(\$ 74 million)	Standing DB/1 or 3 members (required)
Less than JPY 3 billion (\$ 22 million)	Standing DB is recommended

- Establishment of DB shall be discussed and agreed at JICA's Appraisal.
- The entire DB cost shall be included in the total project cost and covered by the JICA loan.

Background: Outline of the DB Survey

• Purpose:

- ✓ Understand good practices / obstacles in DB establishment
- ✓ Draw recommendations for further promotion of standing DBs
- **Duration:** September 2024 July 2025
- Target: 247 contract-lots (contracted in 2018 to 2023)
 125 contract-lots: No provision of standing DB in contract
 52 contract-lots : With standing DB provision but not yet established
 70 contract-lots (28%): Standing DB established
 - → Sent questionnaire to Employers, Contractors and Consultants
 - → Received 467 responses and <u>conducted analysis for 100 contract-lots</u>



Trends: Major Findings of the DB Survey

• Timing of Establishment: Difficult to establish with the deadline

•	Major Obstacle: Appointm	ent and approval of DB membe	ers
	After the contractual deadline	31 lots (70% is being delayed)	
	Within the contractual deadline	13 lots

Appointment and approval of DB members	27	27



Trends: Major Findings of the DB Survey

Informal Opinion: Not yet used, but considered beneficial if used

How many times Informal Opinion (IO) requested?



No. of response

We haven't encountered any situation where we needed to request the DB for an IO.	22
The other Party did not agree to request the DB to seek an IO.	7
We did not know / not informed that we could obtain an IO.	3
The process for requesting the DB to seek an IO is not transparent.	3
We were not convinced that an IO would be beneficial in avoiding a dispute.	3



Trends: Major Findings of the DB Survey

• **Experience of DB:** <u>Avoidance function is largely recognized, and</u> <u>satisfactory level is high</u> (78%: Satisfied + somewhat satisfied)

DBs are effective in avoiding Disputes?





Generally satisfied with the Dispute Board?

Recommendations: JICA's possible actions

- Knowledge sharing seminar: Organize seminar for project owners and relevant government agencies to share good practices (i.e. dispute avoidance mechanism, use of Informal Opinion).
- **DB provision:** Consider changes to facilitate early establishment of S. DB (i.e. set realistic deadline, nominate DB members at bidding stage)
- **DB members:** Closely work with DRBF representatives (i.e. Dr. Castro and Dr. Hardjomuljadi) to <u>increase the number of potential DB</u> <u>members who understand local regulations/context and facilitate</u> <u>early project completion</u> and to prepare a potential member list.
 - → JICA continues to promote Standing DB establishment with close cooperation with DRBF!
